- O Deputies attempted to stop a speeding motorist, traveling in the turning lane on Horseshoe Bend Parkway near Cherokee Road. The driver parked in his driveway and fled into the residence. Deputies applied for and were granted a search warrant for the subject. Upon entry into the residence the subject was in the basement with an AR-15 rifle at his feet, loaded with armor piercing rounds. After a brief struggle the subject was taken into custody.
