

Good evening!! The deputies of the zone responded to 142 calls for service in the month of September which is 48 fewer calls than last month. This is normal since it's the end of the tourist season.

The deputies in the Horseshoe Bend zone responded to seven (7) motor vehicle crashes, four (4) emotionally disturbed persons, five (5) assaults, and three (3) domestic disturbances two (2) sexual assaults amongst other types of calls. They also arrested nine (9) subjects for driving while intoxicated and six (6) subjects for drug possession.

I want to mention two incidents we encountered this month.

A deputy observed a traffic violation and attempted to conduct a traffic stop. The vehicle failed to stop. The deputy pursued the vehicle into Cole County where speeds were averaged between 80-100 mph. Cole County deputies were able to deploy spike strips which flattened a tire on the suspect vehicle. The vehicle came to a stop near the intersection of HWY 54 and HWY 179 near Jefferson City. The driver was taken into custody. The driver already had no bond felony warrants out for their arrest and this is why they decided not to stop.

We received a 911 call at a condo complex. Three subjects showed up and knocked on a door and confronted two subjects about an altercation which occurred the night before. The three subjects ended up assaulting the two subjects. It should be noted the three subjects ended up using small chains wrapped around their fists during the assault. One subject was able to enter the condo and retrieve a firearm. When he came out with the firearm the three subjects left the area. They were identified later in the day. One has been arrested and charged with assault and the other two were juveniles and paperwork has been sent to the juvenile authorities on their behalf. I want to mention the firearm ended up being a BB gun that looked identical to a real Sig Sauer P365 pistol.

Two (2) deputies attended a three (3) day Deputy Sheriff's conference to advance their knowledge in various law enforcement topics. One (1) deputy attended a two (2) day interview and interrogation training and one (1) deputy attended a five (5) day instructor development course to try to get them certified to teach various law enforcement training classes.

The two large tourist draws for September Bikefest and the Jeep Invasion went smoothly this year with minimum additional calls for service.

We want to THANK the Village of Four Seasons board for their support of the deputies who work in this zone as well as the Sheriff's Office as a whole.

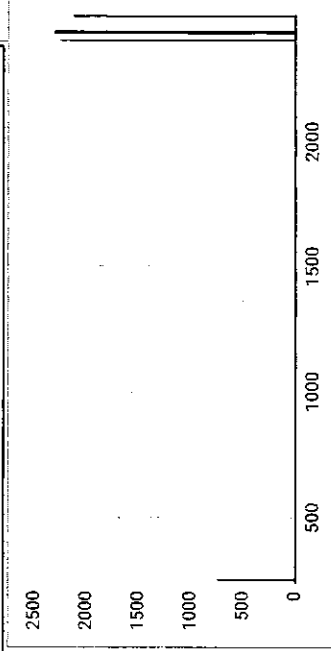

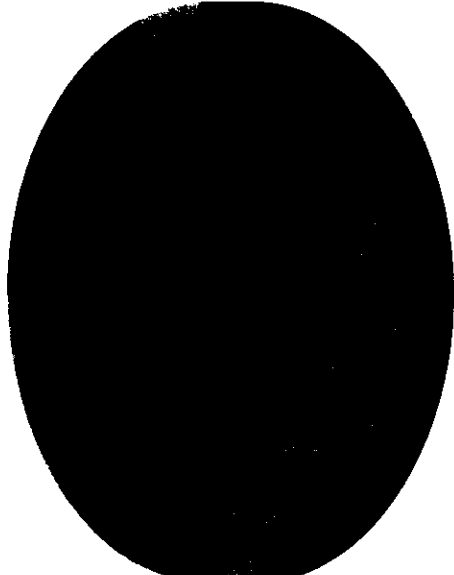
