**INSTRUCTION SHEET**

You have been given a Summons to appear in the Municipal Court Division of the Circuit Court of Camden County, Missouri.

**FAILURE TO APPEAR AT THE TIME DESIGNATED MAY RESULT IN A  
WARRANT BEING ISSUED FOR YOUR ARREST.**

If you wish to plead guilty but do not desire to personally appear in court, you may sign the back of the Instruction Sheet or the Summons the Officer has given you (in the plea of guilty space), complete your address, including zip code, and mail the Summons and Instruction Sheet along with a check or money order in the appropriate amount to the court in the envelope provided.

**NO PARTIAL PAYMENTS WILL BE ACCEPTED**

Before signing the Summons or Instruction Sheet, you should read the explanation of your Rights contained therein. Your signature acknowledges that you waive these rights. The Department of Revenue may assess points against your driver's license and accumulation of excessive points could result in the suspension or revocation of your driving privileges.

**THE SIGNED INSTRUCTION SHEET AND SUMMONS WITH A CHECK  
OR MONEY ORDER MUST BE RECEIVED BEFORE THE COURT DATE  
OR YOU MUST APPEAR IN COURT.**

All fines are to be paid by check or money order and shall be made payable to the Village of Four Seasons Municipal Court. The Summons and Instruction Sheet along with the payment must reach the Court before the appearance date shown on your Summons. A receipt will be returned to you **if you provide a self-addressed stamped envelope**. If no stamped envelope is received, the canceled check or money order will be your receipt; no receipt will be sent by the court.

STATE TREASURY AND VILLAGE GENERAL REVENUE FUNDS.**

I do hereby plead "Guilty" to said offense as charged, waive my right to a hearing by the Court, and agree to pay all fines and costs prescribed for my offense.
