## **Hiking/Biking Trail**

During this past year the Special Road District did some general maintenance work on the trails, such as filling cracks, extending some culverts and restriping. Thanks to the Village and the Special Road District for the ongoing care of the trails, it's a definite asset to our community.

#### **Lodge of Four Seasons - Renovations**

This past Spring a multi-million dollar renovation project began at The Lodge, with completion expected by Summer of 2016. Just about all areas of The Lodge property will be touched, from total sleeping room renovations (windows, beds, etc) to complete replacement of The Lodge's HVAC system, to the widening of the entry road.

The renovation undertaking was made possible by The Four Seasons Group and Access Hotels & Resorts joining forces. ### **Village Storm Sirens**

Sirens are tested the first Tuesday of each month at 11:00 am (weather permitting) and on dates of statewide tests (usually on a Thursday at 1:30 pm). Otherwise the sirens are only activated when a funnel cloud has been sighted in the area; so head for cover if you hear them!

# **Village of Four Seasons vs POA**

If you don't understand the difference between the above two entities don't feel bad as there are many

Village of Four Seasons vs POA - continued long-time residents who don't know. It's pretty complicated and unless you've frequently dealt with either one, you may never really understand the difference. Hopefully the below bullet points will provide a simpler explanation:

- The Village of Four Seasons is a municipality.
- The POA (Property Owners Association) is a private, not-for-profit community association like a homeowners association.
- MAM (Missouri Association Management) is the company the POA contracts with to oversee the operations and amenities of the POA.
- With the exception of certain properties off of Horseshoe Bend Parkway, Bittersweet, Cherokee and several condominium properties, all property in the Village of Four Seasons is part of the POA.
- Likewise, ther are some neighborhoods that are part of the POA that are outside the Village Boundries.
- Permits for various items are often required by both entities (sometimes requiring a fee but not always).
   Refer to enclosed document outlining the specifics of permit requirements.

If any of this it still confusing, or if you are unsure if your property is in the Village or the POA, don't hestitate to contact either enity about this, or anything regarding your community; we are here to help you.

#### **Horseshoe Bend Special Road District**

Snow Removal: Stay alert of possible snow falls that may require snow plowing by the Road District. When plowing is needed, be sure to remove all personal property (vehicles, trailers and other removable property) from the Right of Way in front of your house. Taking these steps will not only protect your property but will also allow the road crew to work more efficiently.

**Permits:** Yes, there are permits to obtain from the Road District. Happily though THERE ARE NO COSTS (they just want to be aware of where improvements are being made since they maintain our roads).

It's also beneficial for property owners to contact the Road District when planning to make any changes on or along the roadway (even replacements) so they can ensure that your planned project will not be located on the Right of Way or become an obstruction during snow events and other road work. (My personal experiences have been pleasant when dealing with the Road District regarding any projects I've had along the road way.)

#### **Emergency Preparedness Corner**

It's winter! Besides having items in your house to get you through a severe winter storm be sure to be prepared while on the road as you never know when you may get stuck and how long before help arrives! A winter emergency kit should be placed in each vehicle and kept there until March or even April.

Below is a basic list of items that should be included in your vehicle kit, but be sure to include anything else you feel you may need in a winter emergency:

# (NOTE: many of the listed items should always remain in your vehicle throughout the year\*)

- Cell phone
- A full tank of gas before you begin trip and if needed, stop occasionally and top off tank\*
- Scraper/brush for windows
- First-aid supplies\*
- Pair of walking shoes (it's difficult to walk very far in heels or work shoes)\*
- At least one flashlight with extra batteries\*
- Brightly colored cloth to signal for help\*
- Flares or reflective triangles\*
- Whistle (in case you slide down a long hill and are out of sight)\*
- Small NOAA weather radio with extra batteries\*
- Tow rope and Jumper cables\*
- Bottled water, a snack, some kind of nonperishable food\*
- Abrasive material, like cat litter, sand or salt

Emergency Preparedness Corner - Continued

- Empty water-tight container with candles, matches or lighter
- Sleeping bags or blankets (to keep warm if you need to wait for a long period of time)
- Ski caps, gloves or mittens (mittens will keep your hands warmer than gloves but are harder to work with than gloves)
- Extra clothes and shoes (If you get wet trying to shovel yourself out or you fall in the snow, you will welcome the change of clothes.)
- Foldable snow shovel (a good one not a flimsy cheap one as you may have to shovel snow or break up ice)\*

You don't have space for these items? You need to find some as you'll be thankful you did if you get stuck!
