

Good evening!! The deputies of the zone responded to 148 calls for service in the month of October besides their self-initiated activities such as residential checks, business checks, traffic stops, etc...

The deputies in the Horseshoe Bend zone responded to five (5) motor vehicle crashes, four (4) emotionally disturbed persons, one (1) assault, and three (3) domestic disturbances and one (1) property damage call amongst other miscellaneous types of calls. They also arrested 16 subjects for driving while intoxicated and five (5) subjects for drug possession.

I want to mention three incidents we encountered this month.

Deputies were dispatched to a domestic assault involving a firearm. We were advised during the argument a subject went and retrieved a firearm from a vehicle and had pointed the RP and then himself. Deputies met with the RP who had left the residence. They then approached the residence and were able to make contact with the suspect. The suspect directed deputies to the firearm and then was arrested and later charged with domestic assault 1st degree and arm criminal action. Deputies also tried to get the suspect evaluated as an emotionally disturbed person.

A deputy stopped a vehicle for several traffic violations. Upon making contact with the driver, he refused to roll down his window more than three inches. He then handed the deputy a piece of paper which was labeled "Hillbilly Press", and then started saying stuff about "treason and common law" which is sovereign citizen ideologies. The suspect refused to exit the vehicle, so deputies extracted him from it. The driver smelled heavily of alcohol and refused to identify himself or perform any field sobriety tests. The driver was arrested for DWI and a search warrant was applied for and granted to obtain a sample of the driver's blood.

A deputy attempted a traffic stop on a vehicle which failed to stop. The vehicle slowed but continued to drive at a slow speed until it finally decided to stop. The driver was requested to exit the vehicle which he did but was agitated and argumentative. He was ordered to lie on the ground which he reluctantly did. When the deputy went to place the subject into custody the driver resisted. An altercation ensued and once a backup officer with his K9 partner arrived the driver was able to be placed into custody. The driver was arrested for several traffic violations as well as drug possession. The passenger was also arrested for drug possession. The deputy was injured in the altercation.

The following celebrated employment anniversaries with the Camden County Sheriff's Office in the month of October: Deputy Jenkins 2 years, Deputy Selby 5 years and Lt. Elkin 28 years.

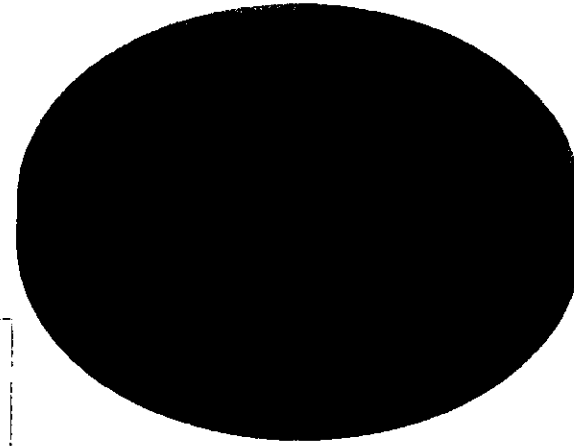

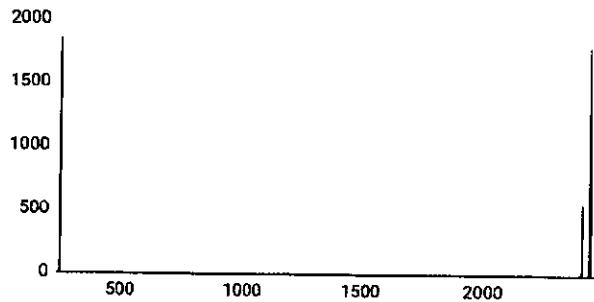
